## GC Resident Has a Say in County Facilities Planning

Glencarlyn resident Steve Young will have an official say on possible new county uses for the urgent care facility adjacent to the neighborhood.

He is a member of the Joint Facilities Advisory Commission (JFAC) launched in November to provide citizen input on this and other issues involving county and

public school facilities. Arlington County could acquire the Virginia Hospital Center (VHC) facility at 601 Carlin Springs Road in a land swap. VHC seeks to expand onto land currently owned by the county.

"I hope we can preserve those chunks of property that are (part of the) scenic easement," on the urgent care property, if it is part of a land swap, Young said. He and other JFAC members recently toured five

potential land swap sites.

Young sits on the JFAC subcommittee developing recommendations on the urgent care site. Young said he is encouraged that the

county has paid attention to a Glencarlyn/Forest Glen survey of residents' views on possible new uses for the site.

Most responding to the survey opposed uses that would increase traffic, include new roads, or degrade the environment.

A large majority of respondents also favored maintaining the green space existing between the urgent care property and the Glencarlyn neighborhood.

In December 2015, the county board gave VHC the option to obtain five acres of county land at 1800 North Edison St..

## Improving GC Mail Service a 'Work in Progress'

Arlington Postmaster Tim Talley said he hopes Glencarlyn residents are seeing some improvement as he works to correct problems with mail delivery in the neighborhood.

He said that actions taken have included a personnel change in the delivery workers covering Glencarlyn.

"It's not perfect (but) I'm not getting near the volume of complaints" about service, he said. "Hopefully people are seeing some improvement."

The postmaster spoke about the delivery issues with participants in the December Glencarlyn Citizens' Association meeting.

## Dues Hike Proposed for GC Residents

The GCA executive committee is proposing a dues increase from \$10 to \$15 per household for the next fiscal year. Dues have not been increased in 12 years. Since that time, we have lost the revenue stream from the rental of Carlin Hall and the cost of printing *The Village View* has increased 35 percent. Expenses for the expanded Glencarlyn Day activities have increased 75 percent. The dues increase will be discussed and voted on at the April 3 GCA meeting.

## Election Matters; Elections Matter

Things don't just happen in Glencarlyn. Events are planned and carried out by elected officers and volunteers. And now's the time to step up.

The Glencarlyn Citizens' Association by-laws call for a nominating committee to be formed to create a slate of Glencarlynites willing to run for office. The committee is to present the slate at the April 3 meeting so that elections can take place at the May meeting.

The new terms begin in June.

# View from the Garden

## A Season of Change for a Master Gardener

After 17 years as a co-coordinator in the Glencarlyn Library Community Garden, Judy Funderburk is stepping back from that leadership role in favor of simply enjoying gardening.

Serving as a leader of the garden, one of five demonstration/teaching gardens maintained by the Master Gardeners of Northern Virginia, is demanding and time consuming, and Judy says she wants to focus on the aspects of the garden she enjoys the most.

“I’m stepping down but not out,” Judy said. “I’m looking forward to continuing to mentor new master gardeners and working side-by-side with fellow gardeners where we both learn and nurture plant/people relationships. Teaching from the garden excites me. Showing people the red buckeye in the spring and the colors of the fothergilla in fall brings me joy.”

A master gardener since 1996, Judy started working in the library garden in 1997. The garden was created in the 1930s by a garden club. It was updated in the early 90s as an Eagle Scout project by Josh Davis, incorporating native plants, benches, and creating the outline of what are now the herb beds. Judy and Paul Nuhn, also a master gardener, have worked together informally to keep the garden maintained. In 1999, the Glencarlyn

Citizens Association asked Judy to develop a Small Parks Grant proposal seeking Arlington’s Department of Parks and Recrea-

tion funds to improve the garden area, which had fallen into disrepair.

The proposal she and a group of neighbors submitted resulted in a grant that paid for signage, entryway arches and other improvements. At about that time, Sue Zajac donated funds for the gazebo in memory of her husband.

With all the improvements and expansion of the garden, Judy and Paul were stretched trying to maintain it, even with help from neighbors. They went through a process of application and documentation to become an official demonstration garden, being approved by the Virginia Cooperative Extension in 2003 and by Master Gardeners of Northern Virginia in 2004. In 2013, Judy and Paul were joined by Alyssa Ford Morel as a third co-coordinator. Each week during the growing season, they lead a group of master gardeners to maintain the garden, supported by a group of community volunteers who each take responsibility

for watering a section of the garden through the heat of the summer. The garden hosts two fund raising events each year: a plant sale in May and AutumnFest in September. Proceeds from the events pay for the upkeep of the garden. The garden also hosts school groups from Campbell and Carlin Springs Elementary, Kenmore Middle and the Carlin Hall Pre-School.

Judy has wracked up more than 6,000 volunteer hours over the years and was recognized last year with the Bill Thomas Outstanding Park Service Volunteer Award.

Health challenges that she and J.Vic Funderburk, her husband of more than 50 years, faced recently, plus turning 75 this past summer, have made her think about priorities and what brings the most joy.

“The aging body complains more often,” she said with a chuckle. “But the amount of time I have had to spend behind the computer is what really makes me grumpy!”

“We’ve had to recruit two people to replace Judy,” said Paul

VHC seeks to expand its North George Mason Drive campus onto the plot, known as the Edison Complex.

The option includes a possible land swap – the Edison Complex for VHC’s urgent care center at 601 South Carlin Springs Road. Other properties are also being considered as alternatives to an urgent care swap.

JFAC was formed by the Arlington County Board and the Arlington Public School Board to review, comment on and make recommendations on capital facilities needs assessments, capital improvement plans, and long-range facility planning by the county and the school system.

That includes identifying opportunities for the county and school system to co-locate, share facilities, and jointly achieve efficiencies in construction timing, according to a description of the panel on the county’s website.

The site notes that “big picture, visionary thinking is encouraged, and the commission should be a forum where...ideas can be discussed freely.”

### ‘Big Picture Thinking’

The commission will also receive and review public comment on these plans and assessments. JFAC meetings are open to the public. The next meeting is scheduled for March 15 from 7-9 p.m. in the Navy League Building, at 2300 Wilson Blvd.

Cooperation and coordination between the public schools and the county government is the “right thing to do,” Young said. “I think that’s just great.”

Young said he was encouraged to apply for one of the 20 JFAC seats and was pleasantly surprised when he was accepted. There were around 80 applicants.

The boards jointly appointed JFAC members based on experience in planning, education, public finance, design and construction, and participation in organizations or processes approved by the county and/or school system.

Membership criteria also included other work or community participation related to the JFAC mission.

Young, who worked 35 years in the Environmental Protection Agency, has been involved in environmental projects within the county for many years — beginning with initiating a program to rid Glencarlyn Park of English Ivy, an invasive species.

He is also a certified Virginia master naturalist. Master naturalists help to conserve and manage natural resources and public lands in Virginia.

Young said he is happy that the county’s natural environment is linked to JFAC through the commission’s county board liaison, Jennifer Fioretti. Fioretti is deputy director of the Arlington County Department of Parks and Recreation.

“To me that’s a major positive,” he said, because the parks and recreation perspective won’t be lost.

## CERT Sets New Member Training



Arlington’s Community Emergency Response Team (CERT) is offering free training to county residents interested in being better prepared for and able to recover from disasters.

The 26-hour course is scheduled for six Tuesday nights and two Saturday mornings from March 14 through April 29. Training follows a national curriculum that covers disaster preparedness, disaster medical operations, fire suppression and utility shut-off, disaster psychology, light search and rescue, team organization, and terrorism. It concludes with a with a mock disaster.

Classes are taught by personnel from the county fire and police departments, the Office of Emergency Management, and by CERT members.

The course is open to those 18 and older — although 16– and 17– year olds may participate if accompanied by an adult/parent.

The all-volunteer CERT is sponsored by Arlington County’s Citizen Corps, Office of Emergency Management and Fire Department.

Nearly 800 county residents have completed the training, according to the Arlington CERT. Many have completed additional training to conduct damage assessments and mitigate hazards following major weather events and to provide support to the county’s emergency management personnel.

Space is assigned on a first-come, first-served basis.

Several residents said they had experienced repeated problems with mail delivery, including:

- Mail delivered to the wrong address.
- Mail on hold delivered regardless of requests.
- Distracted mail carriers leaving letters and packages.
- Questions about cell phone use by mail carriers as a distraction from duties.

One of the steps the postmaster said he has taken is replacing one of the carriers on the Glencarlyn route.

Talley said that he was trying to fill 20 open carrier positions in his jurisdiction.

He told *The Village View* recently that while there have been some new hires, attracting qualified applicants has been difficult. Of 477 potential employees who applied for positions recently, 419 did not pass the first vetting process, Talley said.

He also noted that the high cost of living in the region deters qualified applicants. Talley added that he is going to have a job fair, hoping to attract military veterans to USPS careers.

# Tax Season Brings Out the Con Artists

Thousands of people have lost millions of dollars and personal information to tax scams and Internal Revenue Service (IRS) imposters, according to the federal tax agency.

Here are a couple of the more common cons:

**IRS-impersonation telephone scams** — Targets taxpayers, including recent immigrants. Callers claiming to be IRS employees tell victims they owe money which must be paid promptly



through a debit card or wire transfer or they will be arrested or deported.

These con artists use fake names and bogus IRS identification badge numbers. They may know a lot about their targets and usually alter the caller ID to make it look like the IRS is calling.

**Email, phishing and malware schemes** — Scammers use the IRS name or logo to gain access to consumers' financial information. They use the regular mail, telephone, fax or email to trick taxpayers into believing these are official communications

"I've always seen the garden as a place of rest and beauty that is restorative," she said. "I'm looking forward to continuing the relationships I've built with people in the garden and enjoying the energy of the earth and the plants."

from the IRS or others in the tax industry.

These schemes may ask taxpayers about refunds, filing status, and PIN information. Phishing emails contain the direction "you are to update your IRS e-file immediately." The emails refer to web addresses USA.gov and IRSGov (without a dot between "IRS" and "gov"). The real IRS address is **IRS.gov**

The agency said it will never:

- Telephone demanding immediate payment using a specific payment method. Generally, the IRS will first mail a bill to taxpayers who still owe taxes.
- Threaten to immediately bring in local police or other law-enforcement groups to have you arrested.
- Demand that you pay without giving you the opportunity to question or appeal the amount.
- Ask for credit or debit card numbers over the phone.




