## Surprises and Opportunities Ahead

You never know what is around the corner these days. All of us were completely surprised by the announcement of a mental health facility on the Carlin Springs property. We have worked diligently, and remained in close contact, with County government since before the 2019 land swap. We asked to be kept informed about all plans for the site and thought we have an agreement of "no surprises." That was clearly not the case.

Now as we move forward, we must look at this as an opportunity to benefit our community and the surrounding natural environment. This will take determination and stewardship. We must be the guardians of the natural resources and wildlife surrounding us.

I believe that VHC Health wants to be good neighbors and I look forward to beginning our conversations and planning. There is no doubt that this beautiful natural setting can promote better mental health. An infusion of VHC Health's resources could enhance the Park and Long Branch Nature Center.

There are areas that need to be addressed. These areas fall under the responsibility of the County government and we need to hold them accountable. We ALL know that portions of Carlin Springs Road are not safe for pedestrian traffic. This certainly applies to the area between Glencarlyn and Campbell Elementary school. The County must begin their Carlin Springs Rd traffic study NOW. It cannot wait until FY2025. With this new facility, improvements MUST be made to ensure the safety of our school children, and all pedestrians.

The County must lay out their plans for use of the 5 acres they retain. This land backs right up to our homes. Whatever they are considering must be compatible with our residential community. **And they must share their ideas with us while they are in the planning stages. Not after a decision or "deal" has been made.** What considerations are they taking for noise, lighting, security? How will they ensure the protection of the Salamander Run stream, the Willow Pond vernal pool and the Moses Ball Springs?

There is a 500-space joint-use parking structure in the facility design. **What are they planning that requires 500 parking spaces?** To put that number in perspective, Lubber Run Rec center parking has 130 spaces, Kenmore has 160. And we still have no idea how many stories the medical facility will have.

In the days and weeks ahead, we hope to get many more answers than we have now. The Glencarlyn and Forest Glen Civic Association will remain vigilant, insisting that this project be a collaboration among all interested parties.

And on another topic-

**We are making progress with plans to do a Spring Community Event on the "Kenmore side" of Glencarlyn. Possibly an outdoor movie night with food trucks. More information coming soon.**

## S. Carlin Springs Road Property and VHC Health

(Continued from page 1)

On Jan. 17, Arlington County and VHC Health (formerly known as Virginia Hospital Center) entered into a letter of intent regarding purchase of approximately half of the S. Carlin Springs road site. The agreement was announced after confidential negotiations in the latter half of 2022 with the intent of increasing the number of behavioral care beds in our region. Both the [letter of intent](#) and [news release](#) can be found on <https://www.arlingtonva.us> and linked in the online Village View.

This agreement was made public on January 24 and many Glencarlyn residents learned of it via a Twitter Tweet by County Board Chair [Katie Cristol](#). Several neighbors and GCA President Julie Lee wrote to the Arlington County Board expressing their shock of this announcement. *While all of the letters were in support of improved behavioral facilities, each of the writers expressed dismay in the lack of communication from the County Board to Glencarlyn and neighboring civic associations beforehand.*

Since the announcement and additional discussions with county staff and board members, GCA has learned of the potential relocation of the Animal Welfare League of Arlington (AWLA) to the site.

In early February, residents from 5th and 6th Streets spoke with Board Member Matt de Ferranti in which he urged them to be as active as possible through all avenues of civic engagement with VHC Health and the County Board.

**Any construction on and use of the S. Carlin Springs Road site directly effects our quality of life here in Glencarlyn.**

**Please plan to attend at least one of the two meetings listed one page one and be active with making your voice heard and opinion known.**

### New Engineer Will Work on Kenmore Wooded Area Project

The project's remaining design work, delayed while an open engineering position was being filled, should be moving ahead soon. A new engineer has been hired and will be working on this project.

Once the design information is available, there will be refinement of the draft plan, as was anticipated when the project was approved and funded. Some items that GCA proposed may need to go into a future AN project or be pursued by collaboration between APS and GCA. As the plan is refined, more information will be provided about the scope of the project.

IPC, the invasive control contractor hired by Arlington County, will complete the three remaining invasive treatments during summer and fall of 2023, and summer of 2024. Signs will be posted when the treatments occur and the area being treated will be safe to enter.

Wetland Studies and Solutions, a consulting firm hired by the county, has completed a tree survey. The plan is to evaluate existing trees for removal, pruning or retention once the invasive treatments are complete.

## Missing Middle Housing- FINAL VOTE MARCH 18<sup>th</sup> What Options Remain?

The County Board voted to advertise the Missing Middle zoning amendments. The next step is **the Vote to Enact on March 18<sup>th</sup>**. Here is the overview of the options that remain.

**-Number of Units** -6 units allowed on all R-6 through R-20 lots

**-On-site Parking Minimums**

Best: .5 onsite per unit ( ex: 3 on-site spaces for a- 6 plex)

Worst: no on-site parking requirements

**-Annual Building Cap-**

Best: 58 lots per year ( THREE times the consultants estimate of annual construction)

Worst: NO annual caps

Annual caps would sunset no later than 2028

**NO plan for geographic dispersion** ( ex: all 58 lots could be in one neighborhood)

**-Maximum Gross Floor Area**

Best: Maximums range from 4,800 sq. ft. (2 units) to 8,000 sq. ft. (5-6 units)

Worst: Maximums only for semidetached duplexes (5,000 sq. ft. for 2 units) and townhouse uses (7,500 sq. ft. for 3 units) **No maximum** gross floor area for 4-6 units

**-Interior or Exterior ADUs with semidetached duplexes and townhouses**

Best: ADUs Not allowed

Worst: ADUs Allowed (Increases size of units from 2-3 to 4-6, without additional parking required.)

-There are **NO design standards** to ensure compatibility

-The **amended Tree Canopy wording** is murky at best, using the word “up to 4 shade trees for 2-4 units, up to 8 shade trees for 5-6 units”. Though not the intent, it appears to **leave open the option of no shade trees per unit.**

**There has been no explanation on many of the “details” to this plan**

**Implementation steps and oversight actions are lacking on some of the of the key items.**

# View from the Garden

## Plant This, Not That: Replacing Liriope

Almost every gardener in the U.S. has planted or nurtured at least one invasive plant. They may have even loved it, without realizing the problems it poses. Until fairly recently, there wasn't even a good definition of what an invasive plant or animal was. Executive Order 13112 signed in 1999 finally codified the fact that invasives are (1) not native where they are occurring, (2) able to escape cultivation, and (3) capable of causing harm in the wild to human health, the economy, or the environment.

Embracing that definition and opening our eyes to the problems of invasives can be a rude awakening and hard to accept. Worse, acting on it can be a lot of work. But taking action in our own yards can also be an empowering act of hope for the future of our environment.

One extremely popular plant that has recently been showing its invasive qualities and is on invasive lists in various Northern Vir-

ginia jurisdictions is Liriope, commonly called Monkey Grass or Lilyturf. There are several varieties of Liriope, including clumping *Liriope muscari* and spreading *Liriope spicata*, and while *Liriope spicata*'s running habit is particularly difficult to

control, both are increasingly showing up in wild spaces, crowding out native plants that wildlife depend on.

Liriope was introduced to the U.S. more than 200 years ago from Asia. It is a hardy, evergreen member of the Asparagus family, often used for edging or as a ground cover. It has purple-blue spring flowers and sets blackish berries in

fall. Liriope can be dug out, though it is rarely a one-and-done process. Roots, rhizomes and dropped seeds that hide can sprout and must be dug again. Take heart, repeated effort for two or three years will remove it all.

Fortunately, there are great native plants that support biodiversity and can fill the garden roles played by Liriope. Like Liriope, all three of these choices are evergreen.

*Carex plantaginea* (Plantain-leaved Sedge or Seersucker Sedge) has strappy, rippled leaves. Its bright lime-green color and the maroon and green stripes of its spring inflorescence stalks make it a standout in its preferred shady habitat. Other environmental pluses are that it serves as a larval host for butterflies, birds eat its seeds, and it helps control erosion on banks.

*Phlox subulata* (Moss Phlox) is a standout in sunny areas in spring with bright masses of flowers in shades of pink, purple and white. An American native that has long been available in the nursery trade, this hardy performer stands up to drought, erosion, air pollution and salt. It attracts bees, butterflies and hummingbirds.

*Zizia aurea* (Golden Alexander) shares the dark green color of Liriope, and can take either sun or shade. It's a member of the parsley family and serves as a host of Black Swallowtail butterflies. It has lacy yellow flowers in spring, and is an important support to native bees. It happily spreads by seeds if you need to fill an area from which you have removed *Liriope spicata*.

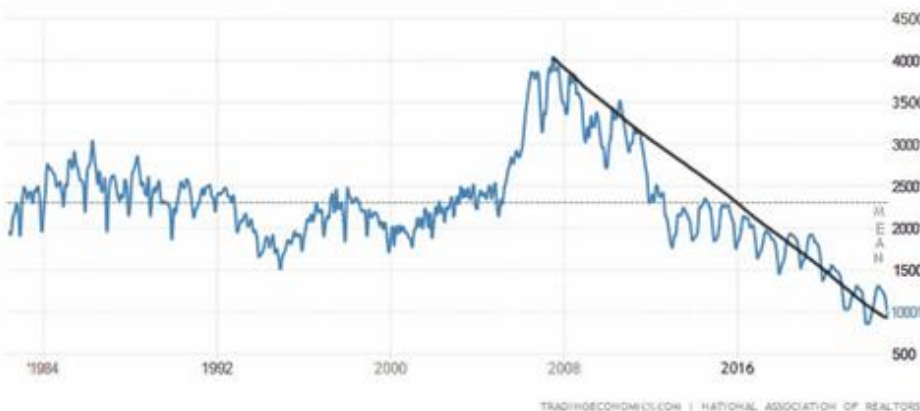
