- Approval process: prove why the mental health service is needed with the state & why VHC is requesting more beds
- Facility will be built on the land furthest from the community
- o 146 beds-96 for outpatient behavioral health and 50 beds for inpatient
- o Mental health is classified as either Substance Abuse or Behavioral
- The group that will stay at the hospital is geriatric psych 55+
- All information is public on the conceptual design- may change with the county review and approval
- SPRC-county review. 4.1 site plan which includes Civil engineering & landscaping. This does not start until you submit the 4.1 plan. VHC has never done a behavioral health hospital, they wanted to do it alone. Eventually selected a partner instead and signed a definitive agreement. Cannot say who it is because their staff is not aware yet. Will be public knowledge soon
- VHC is 51% owner and partner is 49%
- What's next? Before submitting 4.1, they have to meet with the county. Meeting with county on 11/18. After they will finalize 4.1 plan. Aiming for submission to county by EOY. County take about a month or month and a half to review. After that, 2-3 monthsthe county will put together the SPRC involving multiple groups. Those are open to the public and are focused on central topics
- o The hope by end of 2025 it would be fully approved. 18-24 months for construction
- Building size: 2 buildings, 2 levels. 1 tower for outpatient and 1 patient for inpatient with a connecting tunnel. Parking would be underground
- Number of employees: over 300
- o Acute care only: no residential
- \$160 million to build facility as of right now
- What would they do differently after the VHC pavilion project? 1. Lighting 2. Noise 3.
 Landscaping 4. Traffic —-> better community engagement to use as a guide to
- o Pre traffic study- redo while school is in session
- Follow up: Open meeting for Glencarlyn, Forest Glen, and Arlington Mill Residents before 4.1 submission. Will be sometime in December of January
